**CRIMINAL COMPLAINT**

The undersigned, under penalty of perjury, complains and says that on or about the 12th Day of February 2016, In the County of Bernalillo, State of New Mexico, the above-named defendant(s) did (here state the essential facts):

On February 9<sup>th</sup> 2016 US Marshals Fugitive Task Force Officers made contact with DeAmber Yonker at the Family Advocacy Center located at 625 Silver SE. This contact was in regards to her boyfriend Darrius Valles who is actively fleeing from Law Enforcement on an Open Count of Murder that occurred on January 15<sup>th</sup> 2016. Detectives received information from a reliable source that DeAmber had fled to California with Darrius and had been assisting evade capture. During my interview with DeAmber she lied to detectives about where and who she was with. DeAmber stated she was not with Darrius, and refused to provide any information.

February 10<sup>th</sup> and 11<sup>th</sup> 2016 USMS received information that Darrius was in Roswell NM. Detectives arrived in Roswell and made contact with Yondi Aguirre and Ezekial Warner. Both subjects admitted to transporting both Darrius Valles and DeAmber Yonker from California to Las Cruces NM, where DeAmbers mother and sister picked her up. They continued with Darrius to Roswell, and then on February 11<sup>th</sup> transported him to Albuquerque.

February 12<sup>th</sup> 2016 I made contact with DeAmber Yonker at her sisters house and confronted her with the information that we knew she was assisting Darrius evade capture. DeAmber continued to lie and provide false statements and information to Law Enforcement. Eventually DeAmber admitted to being with Darrius in California and coming back to New Mexico.

DeAmber was booked into MDC without incident, and a copy of this will be forwarded to the District Attorneys Office.
