

## COUNT 2:

CRIMES: HOMICIDE (Second Degree), and Aggravated Battery on a Household Member (2 counts).

The undersigned, being duly sworn, upon oath, complains and says that on or about the dates set forth below, in San Miguel County, State of New Mexico, the abovenamed defendant did:

#### COUNT I

Commit the offense of **HOMICIDE** (Second Degree), in that on or about the 16<sup>th</sup> day of February 2010, in San Miguel County, State of New Mexico, the above-named defendant did kill another human being, **Margaret Garcia**, and knew that his acts created a strong probability of death or great bodily harm to Margaret Garcia, and that defendant did not act as a result of sufficient provocation, contrary to § 30-2-1 (B), NMSA 1978, a **Second Degree Felony**.

## COUNT II

Commit the offense of AGGRAVATED BATTERY AGAINST A HOUSEHOLD MEMBER, in that on or about the 16<sup>th</sup> day of February 2010, in San Miguel County, State of New Mexico, the above-named defendant did unlawfully touch or apply force to the person of Ralph Garcia, with intent to injury said person, and did

## AFFIDAVIT FOR ARREST WARRANT

The undersigned being duly sworn, on his oath states that he has reason to believe that on the 16<sup>th</sup> day of February 2010, in the county of San Miguel, State of New Mexico, the above-named Defendant did commit the crime (s) of:

Murder (second degree)
Aggravated battery upon a household member (2 counts)

The undersigned further states the following facts on oath to establish probable cause to believe that the above-named defendant committed the crime charged: (include facts in support of the credibility of any hearsay relied upon).

On February 16, 2010 at approximately 4:30pm Officers of the Las Vegas Police Department responded to a call for service at regarding a domestic disturbance. Upon officers arrival contact was made with two individuals on the ground in the front yard area. A Ms. Margaret Garcia who was lying on the ground in the front yard. And a Mr. Robert Garcia who was lying on the ground on the porch. During the officers observation they observed blood on the face of both Mr. Robert Garcia and Margaret Garcia, also their faces appeared bruised and swollen. Officer also came in contact with a Mr. Ralph Garcia who was seen outside the front yard area holding a large pipe in his hands. Mr. Ralph Garcia was detained until further investigation. While on the scene Officers were informed of another male subject in the home. At this time, Mr. Ryan Garcia exited the home. Mr. Ryan Garcia was detained until further investigation.

While at the scene, through brief interviews of victims and witnesses, it was discovered that Ryan was the aggressor in the disturbance. It was found that Ryan was the person to inflict injury to Mr. Robert Garcia, Margaret Garcia and Ralph Garcia. Through these interviews it was discovered that Ryan was upset because he was not allowed to open a package left at the home by the mailman for the neighbors. It was discovered that Ryan became enraged and

began to punch his uncle Robert in the face. Ryan then turned to his grandmother Margaret and began punching her in the face. Ryan then grabs his grandmother and throws her out the front doors. Ms. Margaret Garcia is said to have fallen off of the porch head first, onto the cement. It is said Ryan then grabbed his uncle Robert, dragged him outside onto the porch and began punching and kicking him. Ryan then turned to his grandmother Margaret and began punching and kicking her as she lay on the ground. At this time, Ryan's father a Mr. Ralph Garcia arrives at the home from going to the store. It is said Ryan throws a glass bowl at him striking him in the face. Ryan then grabs a metal pipe and began striking his father with it. During a struggle, Mr. Ralph Garcia is able to take the pipe away from Ryan. As Officers arrived, subjects were detained and victims treated. Mr. Robert Garcia and Margaret Garcia were transported to the Alta Vista Regional Hospital for their injuries.

Shortly after being transported to the Alta Vista Regional Hospital, Ms. Margaret Garcia was airlifted to University of New Mexico Hospital in Albuquerque New Mexico. While there Ms. Margaret Garcia's condition worsened.

Also transported to University of New Mexico Hospital days later was Robert Garcia.

On February 19, 2010 I received information that Ms. Margaret Garcia succumbed from her injuries, inflicted by her grandson Ryan Garcia during the incident on February 16, 2010. Ms. Garcia was pronounced dead at 7:53am on February 19, 2010.

Mr. Robert Garcia was released from University of New Mexico Hospital in the evening of February 19, 2010.

WHEREFORE, Affiant prays that this court immediately issue an Arrest Warrant for the above-named Defendant and for such further relief as this Court deems just and proper.
