CRIMES CHARGED

SECOND DEGREE MURDER AND VOLUNTARY MANSLAUGHTER (0001); HOMICIDE BY VEHICLE (RECKLESS) (0017); KNOWINGLY LEAVING THE SCENE OF AN ACCIDENT (GREAT BODILY HARM OR DEATH) (1362); AGGRAVATED ASSAULT (DEADLY WEAPON) (2 COUNTS) (0056)

GRAND JURY INDICTMENT

THE GRAND JURY CHARGES:

TB COUNT 1: SECOND DEGREE MURDER AND VOLUNTARY MANSLAUGHTER (0004)

That on or between April 30, 2017, in Bernalillo County, New Mexico, the above-named defendant did murder Daniel Arballo, and knew that his acts created a strong probability of death or great bodily harm, contrary to §30-2-1(B) AND FURTHERMORE, the defendant is hereby notified that upon trial of this cause the finder of fact may be instructed to consider voluntary manslaughter, contrary to §30-2-3, NMSA 1978.

TB COUNT 2: HOMICIDE BY VEHICLE (RECKLESS) (0017)

That on or between April 30, 2017 and May 1, 2017, in Bernalillo County, New Mexico, the above-named defendant did kill Daniel Arballo, a human being, in the unlawful operation of a motor vehicle while violating §66-8-113, NMSA 1978 (Reckless Driving), contrary to §66-8-101(A)&(C), NMSA 1978, as amended.

TB COUNT 3: KNOWINGLY LEAVING THE SCENE OF AN ACCIDENT (GREAT BODILY HARM OR DEATH) (1362)

That on or about April 30, 2016, in Bernalillo County, New Mexico, the above-named defendant did drive a motor vehicle involved in an accident resulting in the death of Daniel Arballo, and knowingly failed to stop or comply with the requirements of §66-7-203, NMSA 1978, contrary to §66-7-201(A)&(C), NMSA 1978.

TB COUNT 4: AGGRAVATED ASSAULT (DEADLY WEAPON) (0056)

That on or about April 30, 2017, in Bernalillo County, New Mexico, the above-named defendant did assault or strike at Billy Harper, with a vehicle, an instrument or object which, when used as a weapon, could cause death or very serious injury, contrary to Section 30-03-02(A), NMSA 1978.

TB COUNT 5: AGGRAVATED ASSAULT (DEADLY WEAPON) (0056)

That on or about April 30, 2017, in Bernalillo County, New Mexico, the above-named defendant did assault or strike at Billy Harper, with a shovel, an instrument or object which, when used as a weapon, could cause death or very serious injury, contrary to Section 30-03-02(A), NMSA 1978.
