ORDER SETTING CONDITIONS OF RELEASE

IT IS HEREBY ORDERED that the defendant be released after complying with the following conditions:

ROR – The Defendant is released on her/his own recognizance

BOND IS SET IN THE SUM OF: Twenty five thousand (\$ 25,000)

and the Defendant and his/her sureties will execute a bond binding them to pay to the State of New Mexico the amount set, in the event the Defendant fails to appear as required or otherwise fails to comply with any of the conditions of release set forth below. The bond must be posted as follows:

[X] SECURED by SIGNATURE – by the Defendant and his/her sureties.

[ ] CASH ONLY – the posting of the entire sum of the bond set.

[ ] CORPORATE SURETY – the posting of a security for the full amount of the bond by a certified and approved bonding company.

[ ] 10% CASH DEPOSIT – the deposit of 10% of the bond in cash into the court registry.

[ ] PROPERTY – posting of encumbered real estate to cover the amount of the bond.

[ ] NO RELEASE ON PERSONAL RECOGNIZANCE or on an UNSECURED APPEARANCE BOND. Neither will reasonably assure the appearance of the Defendant or secure the safety of any other person or the community.

[ ] THIRD-PARTY CUSTODY RELEASE TO

I/We agree to supervise the Defendant; to use every effort to assure his/her appearance at all scheduled hearings; and to notify the Court immediately in the event the Defendant violates any conditions of release. I understand that I may be subject to contempt sanctions if I fail to comply with these requirements.
