**GRAND JURY INDICTMENT**

**THE GRAND JURY CHARGES:**

Count 1: **HOMICIDE BY VEHICLE (7108)**, in that on or about the 9<sup>th</sup> day of April, 2017, in Santa Fe County, New Mexico, the above-named Defendant did kill a human being, to wit: STEFAN SIEGMANN, while in the unlawful operation of a motor vehicle, while Driving Under the Influence of Intoxicating Liquor and/or Drugs, contrary to NMSA 1978, Sections 66-8-101(A)(C) and 66-8-102.

Count 2: **GREAT BODILY INJURY BY VEHICLE (1462)**, in that on or about the 9<sup>th</sup> day of April, 2017, in County, New Mexico, the above-named Defendant did cause great bodily injury to PAMELA REYES, while in the unlawful operation of a motor vehicle, while violating, NMSA 1978, Section 66-8-102 Driving While Under the Influence of Intoxicating Liquor or Drugs, contrary to NMSA 1978, Sections 66-8-101(B) and 66-08-102.

Count 3: **GREAT BODILY INJURY BY VEHICLE (1462)**, in that on or about the 9<sup>th</sup> day of April, 2017, in County, New Mexico, the above-named Defendant did cause great bodily injury to JOSE CHAVEZ, while in the unlawful operation of a motor vehicle, while violating, NMSA 1978, Section 66-8-102 Driving While Under the Influence of Intoxicating Liquor or Drugs, contrary to NMSA 1978, Sections 66-8-101(B) and 66-08-102.
