GRAND JURY INDICTMENT

THE GRAND JURY CHARGES:

Count 1: **HOMICIDE BY VEHICLE (0017)**, in that on or about the 16th day of December, 2016, in Santa Fe County, New Mexico, the above-named Defendant did kill a human being, to wit: CHRISTOPHER BYRANT, while in the unlawful operation of a motor vehicle, while violating NMSA 1978, Section 66-8-113 Reckless Driving, contrary to NMSA 1978, Sections 66-8-101(A) and 66-8-113.

Count 2: **HOMICIDE BY VEHICLE (0017)**, in that on or about the 16th day of December, 2016, in Santa Fe County, New Mexico, the above-named Defendant did kill a human being, to wit: IVAN SWEATT, while in the unlawful operation of a motor vehicle, while violating NMSA 1978, Section 66-8-113 Reckless Driving, contrary to NMSA 1978, Sections 66-8-101(A) and 66-8-113.

Count 3: **DUTY TO GIVE INFORMATION AND RENDER AID (6689)**, that on or about the 16th day of December, 2016, in Santa Fe County, New Mexico, the above-named Defendant did drive any vehicle involved in an accident resulting in injury to or death of any person or damage to any vehicle which is driven or attended by any person shall give his name, address and the registration number of the vehicle he is driving and shall upon request exhibit his driver's license to the person struck or the driver or occupant of or person attending any vehicle collided with and shall render to any person injured in such accident reasonable assistance, including the carrying or the making of arrangements for the carrying, of such person to a physician, surgeon or hospital for medical or surgical treatment if it is apparent that such treatment is necessary or if such carrying is requested by the injured person, contrary to NMSA 1978, Section 66-7-203.
